<b>Special</b>	<p><b>Farm Structures that are in <u>excellent</u> condition with the following superior characteristics:</b></p> <ul style="list-style-type: none"> <li>a) No floor or loft above the ground level unless for residential use</li> <li>b) Continuous masonry or concrete foundation</li> <li>c) Ground floor must be incombustible throughout</li> <li>d) Fully enclosed—additions are subject to approval by UW</li> <li>e) No exposed insulation</li> <li>f) Used for its original purpose—submit for exception</li> <li>g) Does not contain hay or straw</li> <li>h) Metal grain storage bins (without heat) used <u>exclusively</u> for bulk storage of grain</li> </ul>
<b>Broad</b>	<p><b>Farm structures that are in <u>very good</u> condition and have the following characteristics:</b></p> <ul style="list-style-type: none"> <li>a) Characteristics a) through c) above</li> <li>b) Hay storage at ground level</li> <li>c) Enclosed on at least three sides</li> <li>d) Metal ground storage bins (with heat) used <u>exclusively</u> for bulk storage of grain</li> <li>e) Cement or steel silos</li> </ul>
<b>Basic</b>	<p><b>Farm Structures that are in <u>good</u> condition and have the following characteristics:</b></p> <ul style="list-style-type: none"> <li>a) Structures not eligible for Special or Broad</li> <li>b) All fabric covered structures, hoop buildings, portable buildings and greenhouses                             <ul style="list-style-type: none"> <li>1. Replacement cost available for covers or structures that are <b>10</b> years old or less</li> <li>2. ACV must be used on all buildings with covers or structures more than <b>10</b> years old</li> <li>3. Personal greenhouses not used in farming are Coverage B property</li> </ul> </li> </ul>
